Co-Contributions

For anyone assessed by My Aged Care after 12 September 2024, client co-contributions apply.

The government, not Helping Hand, sets the level of contribution that you pay, and this changes depending on your level of income and assets. Services Australia will let you know what co-contributions you are eligible to pay. The rate is based on the type of service received:

No contribution for clinical support services

(such as nursing, or physiotherapy) - the government will fully fund clinical care services.

- 0% contribution for full and part pensioners, and self funded retirees.

Moderate contributions for independence services

(such as personal care) and products and equipment.

- 5% contribution for full pensioners
- 5-50% contribution for part pensioners (means tested)
- 50% contribution for self funded retirees

Higher contributions for everyday living services

(such as domestic assistance and gardening), as the government does not typically fund these services for anyone at other stages of life.

- 17.5% contribution for full pensioners
- 17.5-80% contribution for part pensioners (means tested)
- 80% contribution for self funded retirees

Hourly Rates

All rates in the fee schedule overleaf are average hourly rates unless otherwise specified.

All services are billed in 15 minute increments, depending on agreed length of service in your Care Plan as per assessed need.

Care Management Fees

The government allocates 10% of your Support at Home funds for Helping Hand to use for Care Management purposes. Co-contribution does not apply for Care Management Fees.

Care Management is divided into three levels:

Essential: general enquiries and questions about your services

Enhanced: care management support for more detailed enquiries, support with reassessment, and changes to your plans or budgets

Clinical / Complex: care management related to clinical needs and support, and complex enquiries.

Cancellations

A cancellation fee will be charged in the following situations:

- when the client is not home at the time of the service (without notification)
- if the client turns the worker away upon arrival
- if the service is cancelled with less than 2 business days' notice

Clinical Care and Allied Health Services

*Clinical Care Services, including allied health and nursing: the rates in this section represent the average rate per hour. Prices may vary depending on clinical care needs, including assessments and documentation.

All Allied Health Professional appointments require documentation time in addition to appointment time. Time is determined by service and will be charged in addition to appointment time.

Allied Health Professional services include Physiotherapy, Podiatry, Social Work, Occupational Therapy, Dietetics, and Exercise Physiology.

Telehealth appointments are charged at clinic visit rates.

Social Support: Groups

*Social Group prices are based on the specific social group you wish to participate in. The price listed in this fee schedule represents the average price per hour and does not include incidentals (ie the cost of meals, transport, tickets to events).

Transport Services

[^]Transport Services are billed per one way trip (ie picking up a client from their home and driving them to their destination is one trip. Taking the client back home is a second trip.) The price per trip in this fee schedule is an average.

Meals

⁺Meal prices are based on a per meal delivered basis. This is an average price and depends on client preferences, dietary requirements, and nutritional requirements.
